

DECLARATION OF POOLING

WHEREAS, Encana Oil & Gas (USA) Inc. is the owner of certain interests under the Oil and Gas Leases ("Leases") set forth on Exhibit A attached hereto insofar as the Leases cover the N/2S/2NW/4NW/4 of Section 12, Township 7 South, Range 92 West, 6th P.M. and the S/2S/2NW/4NW/4 of Section 12, Township 7 South, Range 92 West, 6th P.M., Garfield County, Colorado.

WHEREAS, each of the Leases provides the Lessee thereunder the right to unitize or pool the Leases and the lands covered thereby, in whole or in part, so as to create a unit or pool as may or may not be required to conform with applicable rules and orders of the Colorado Oil and Gas Conservation Commission.

NOW THEREFORE, acting under and by virtue of the pooling authority contained in the Leases, the undersigned does pool, combine and designate the following lands (and the leasehold, mineral and royalty rights thereunder) as a unit for the purpose of drilling the Twin Creek 12-4D1 (F12E) well and producing oil and/or gas and associated liquid hydrocarbons from the Williams Fork formation therein:

NOW THEREFORE, production from the Twin Creek 12-4D1 (F12E) well shall be allocated fifty percent (50%) to the N/2S/2NW/4NW/4 of Section 12, Township 7 South, Range 92 West, 6th P.M. and fifty percent (50%) to the S/2S/2NW/4NW/4 of Section 12, Township 7 South, Range 92 West, 6th P.M., Garfield County, Colorado.

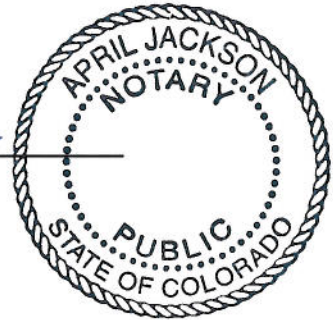
