There are no domestic /irrigation water wells for at least a mile radius, though several groundwater monitoring wells are nearby. The Hillsboro Ditch is approximately 3350 feet to the east. The tank battery equipment on this site (within the designated OGOA on the SUA) will service the following wells: McCarty #20-21, #20-21-9, #20-21-16, #2 (API#05-123-10514), #10-21 (API#05-123-26729), #10-21-23, #10-21-24, #15-21-37 (eight wells in total)
