This location assessment is for the construction of the new RWF 34-31 well pad. There will be a total of 14 wells drilled. Surface and minerals are owned in fee. The location reference point for this pad is the RWF 33-31 well from which all measurements were taken. Reference photos will be provided at a later date after snow melt. Williams will employ the following BMP's to support protection of surface and ground water: 1) Williams will ensure 110% secondary containment for fluids contained at well site during drilling and completion operations. 2) Williams will implement best management practices to contain any unintentional release of fluids. 3) A closed loop mud system will be used.
