We will be setting a pumping unit sometime in the future as determined by daily production. The nearest Railroad is greater than 1 mile from location. Reference area is located adjacent to and on undisturbed land East of the Oil and Gas Location. Location photo is reference area photo. Sensitive area due to location in Northern High Plains Designated Groundwater Basin. Separator may be set at meter shed if determined necessary. This location was originally permitted under Berry Petroleum, but Augustus Energy purchased Berry Petroleum 04/01/09 and Augustus would like to refile this location using the existing API #05-125-11670. A change of operator was submitted (1/11/10) changing the location from Berry to Augustus. Augustus did move the location approx. 250 north of the original permitted location. Otherwise, all conditions remain the same. The 6.65 acre tract is a water line ROW. Sundry to change operator was submitted 01/11/10 and approved 01/19/10. Otherwise all conditions remain the same. The proposed location will be approx. 50' east of a lease line; encroaching on is apx. 6.65 acres; the Exception Location Request & signed Waiver attached to Form 2 6-17-10 JLV.
