Nearest building, public road and railroad are greater than 5280' from the proposed production facility location. Nearest surface water is greater than 5280' from the proposed production facility location. Nearest water well depth to ground water was taken from Receipt #9059911 Permit #7896. The reference area is on undisturbed ground immediately adjacent to the location to the north of drillsite location as depicted in the facility location facing north. The Abbey D01-23 will be separate from and built 30' east of the existing Kerr-McGee production facilities for the HSR-Guttersen 15-1 & 16-1. Therefore, the facilities for the Abbey D01-23 will consist of 1 separator, 1 water vault, 1 tank, 1 three-phased flowline, 1 gas pipeline and 1 EFM.
