The Noffsinger 2RD, Noffsinger 2C, 31-2D, 32-2D, 2SD and 2VD wells will be drilled from the same pad. The wells will be tied into an existing tank battery located at the Frudden #1 well. A new 2A will be filed if necessary for the tank battery.
