Location falls within pen area of former hog farm. Land will be reclaimed by surface owner following demolition of remaining buildings and improvements. Closest ACTIVE power line is 206 ft west. There are two de-energized lines 38 and 21 ft from stake location. Buildings in SW 1/4 Sec 19 are abandoned or demolished. Distance to nearest public road and railroad is greater than 1 mile. Water well permit #35644 located NENE25-5N-63W. Other wells on CDWR are abandoned monitoring wells.
