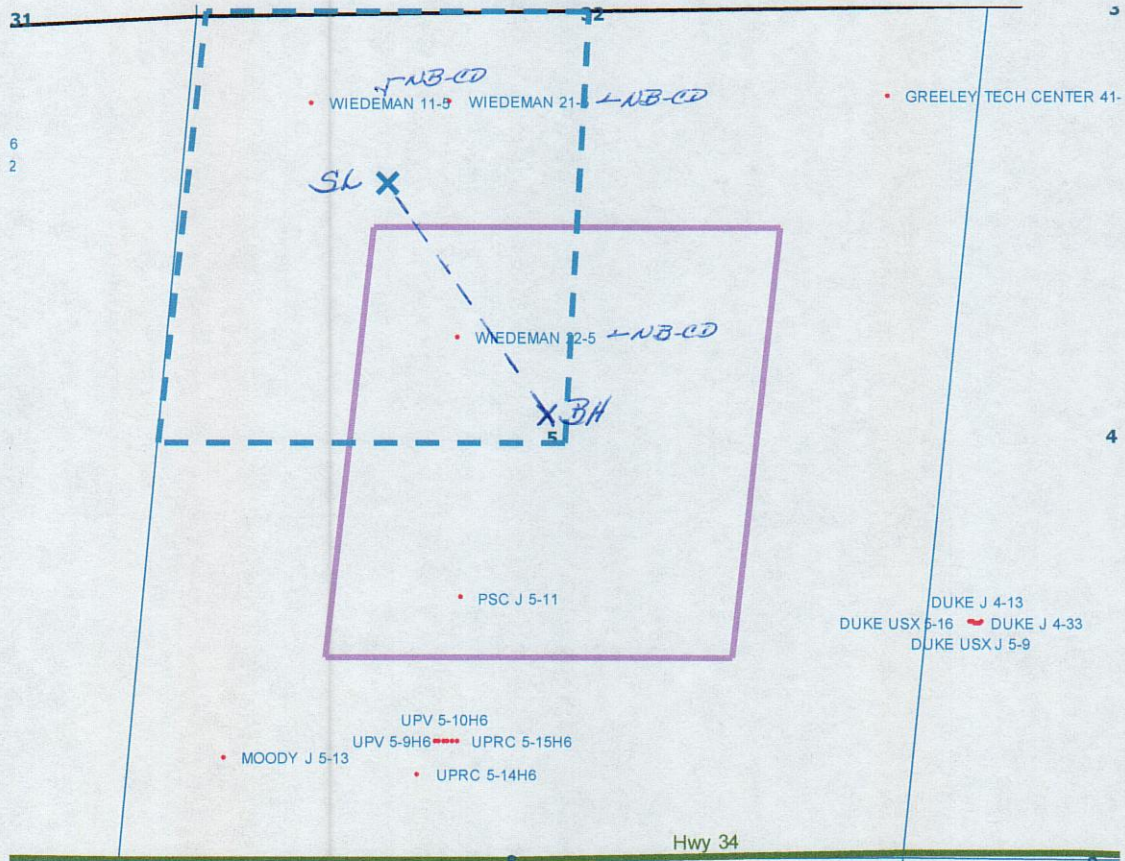

Proposed 160 acre Spacing Unit (Solid line).



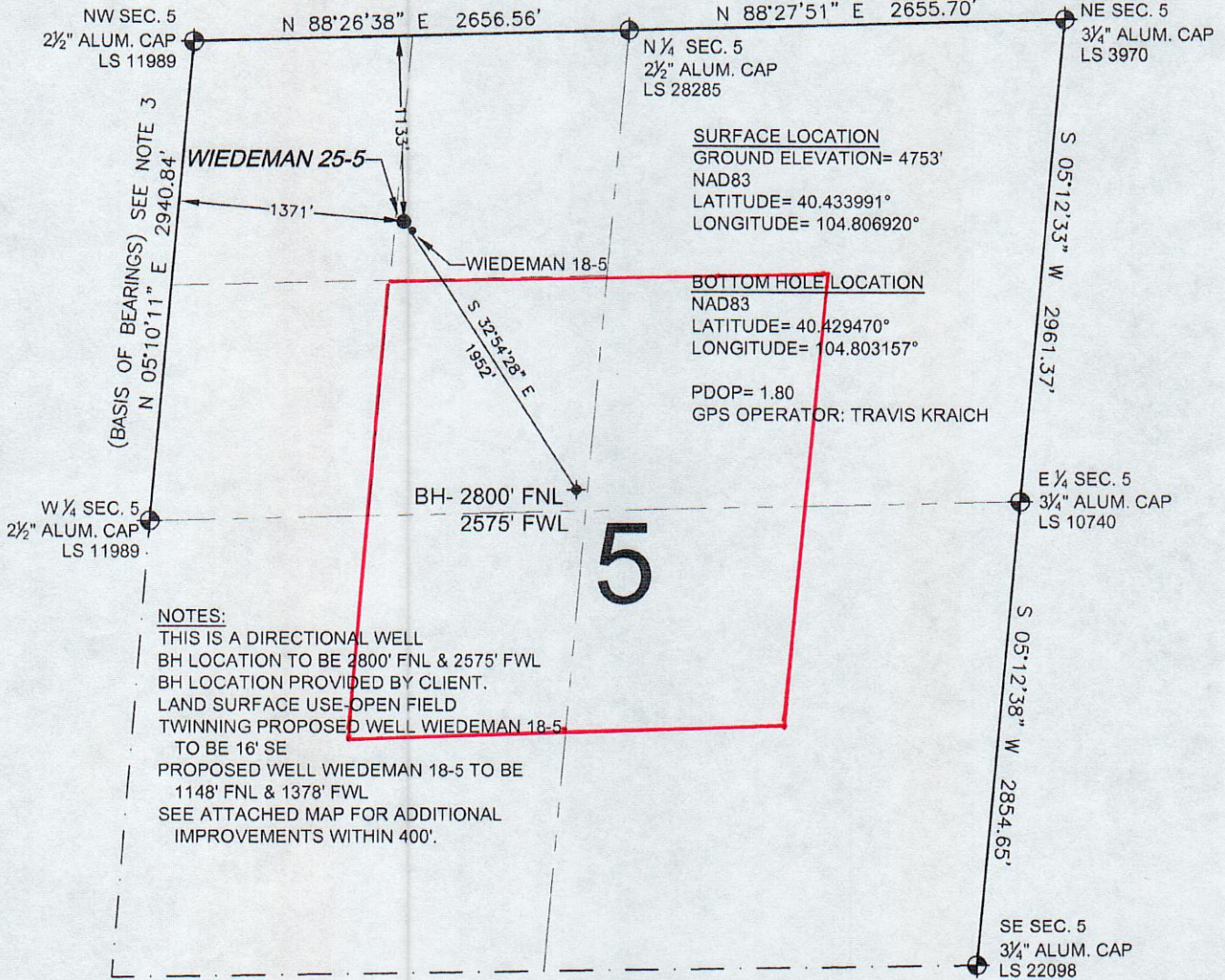
Bottom Hole Located SE/4NW/4, Sec. 5-T5N-R66W (Dashed line).

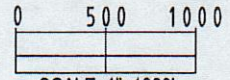
