Nearest railroad is greater than 5280'. COGCC map shows the nearest water well located 28' NE of proposed Guttersen D10-30D. A visual on-site inspection was completed and the nearest water wells were located 600' and 680' of the proposed well location. A consultation confirmed that the positions and surface owner has given consent to drill the Guttersen D10-30D. The surveyor located these 2 wells at the Ranch house, but do not show on the COGCC website. Surface water Box Elder Creek is approx. 553'. Nearest water well depth to ground water was taken from Receipt #9064380 Permit #4417. The proposed Guttersen D10-30D is located 47;' SE of the existing Karch White D9-1. The reference area is on undisturbed ground immediately adjacent to the location to the west of drillsite location as depicted in the staked location facing west.
