The Hillsboro Ditch is approximately 868 ft. to the east. The location will have a currently producing well, McCarty #1, API# 05-123-10232, and 2 staked locations at 50' (McCarty #19-22-13) and 100' (#19-22-12) from the existing well. The tank battery facility located in this Oil and Gas operations area will service these wells. Details of the well location are on the well plats attached.
