Pioneer understands that the COGCC will attach a COA on this well that it cannot be produced until the existing well is plugged and abandoned. If a pit liner is used, it will be properly managed as solid waste when the pit is closed in accordance with state rules. The water well used to determine the static water level is receipt #0527293. The reference area is an undisturbed area, adjacent to, and to the south of the well pad.
