Water well permit #177928 was used to determine depth to ground water. The LAJCO 17C, 17RD, 17SD, and 17ND will all be drilled from the same pad. The wells will be tied into a tank battery facility located at the site which will also service the Comings 17-3 and 17-4 wells. Please note that the LAJCO 17C SHL is being moved from the location of 1366' FNL, 1172' FEL, which was previously permitted, to 1369' FNL, 1150' FEL.
