Conductor casing will not be used. The Leffler 2TD and 2XD will be drilled from the same pad. The Leffler 2XD will be twinning the Leffler 44-2 which is an existing well. The wells will be tied into an existing tank battery facility which currently services the Leffler 43-2, 2D and 44-2 wells. A separate 2A will not be filed because the additional equipment needed for the tank battery will fall within the originally disturbed area. Water well permit #1598-R-R was used to determine depth to ground water.
