Location drawing from SUA with Envirotech indicates where access needs to be situated, 200' setback on tank battery is changed by SUA, metal berm is in place to separate the tanks from the mag-chloride pit to the west. A separate informational form 2A will be filed before this well location is drilled. Pits for mag-chloride production are lined and not in contact with the surface waters of this area.
