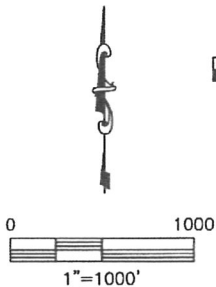
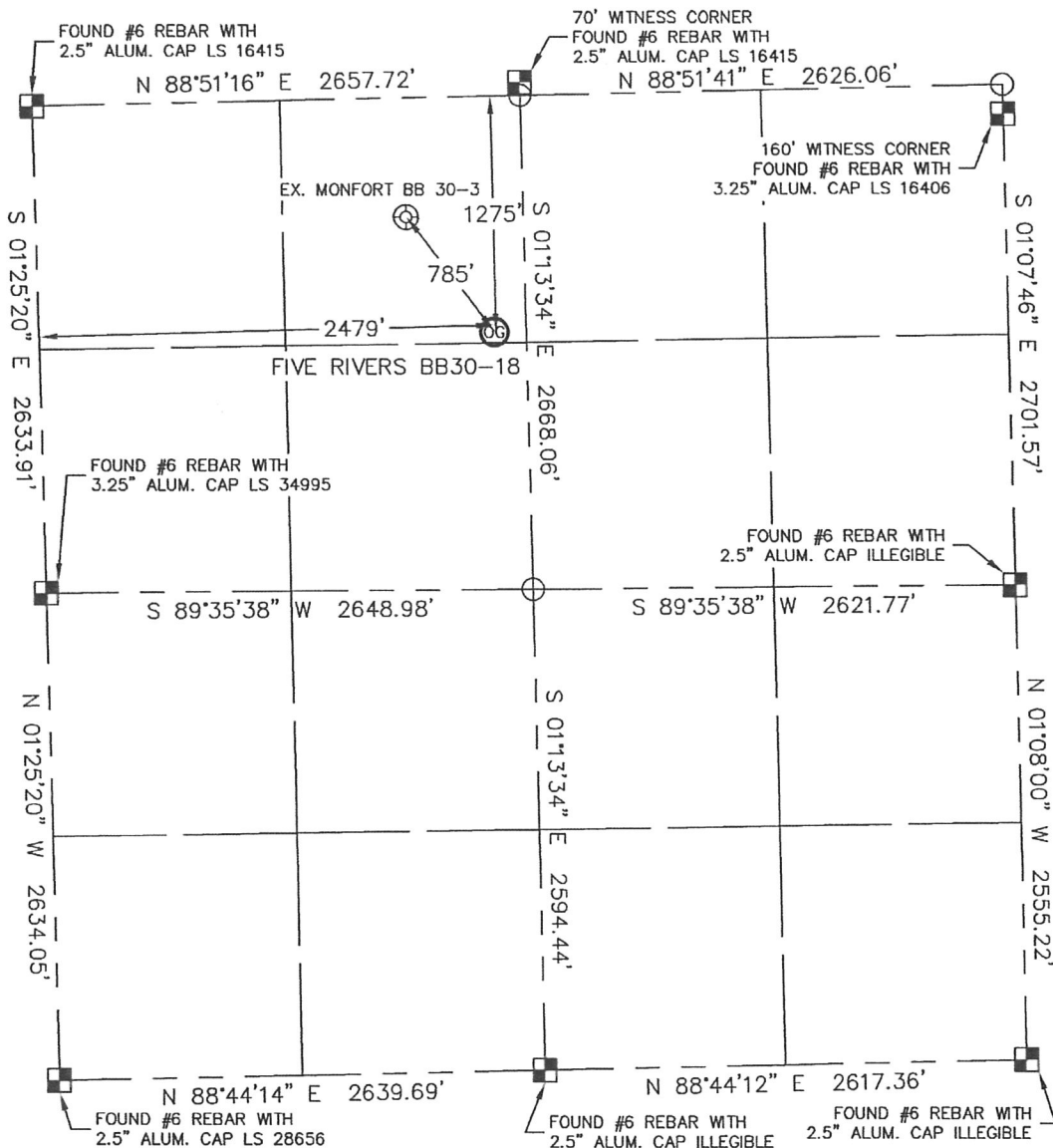


WELL LOCATION CERTIFICATE

In accordance with a request from JOE MARTIN with Noble Energy Inc., Lat40°, LLC has determined the surface location of the FIVE RIVERS BB30-18 to be 1275' from the NORTH line and 2479' from the WEST line as measured at right angles from the section line of Section 30, Township 5 North, Range 63 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 5/10/10, for and on behalf of Noble Energy Inc.. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

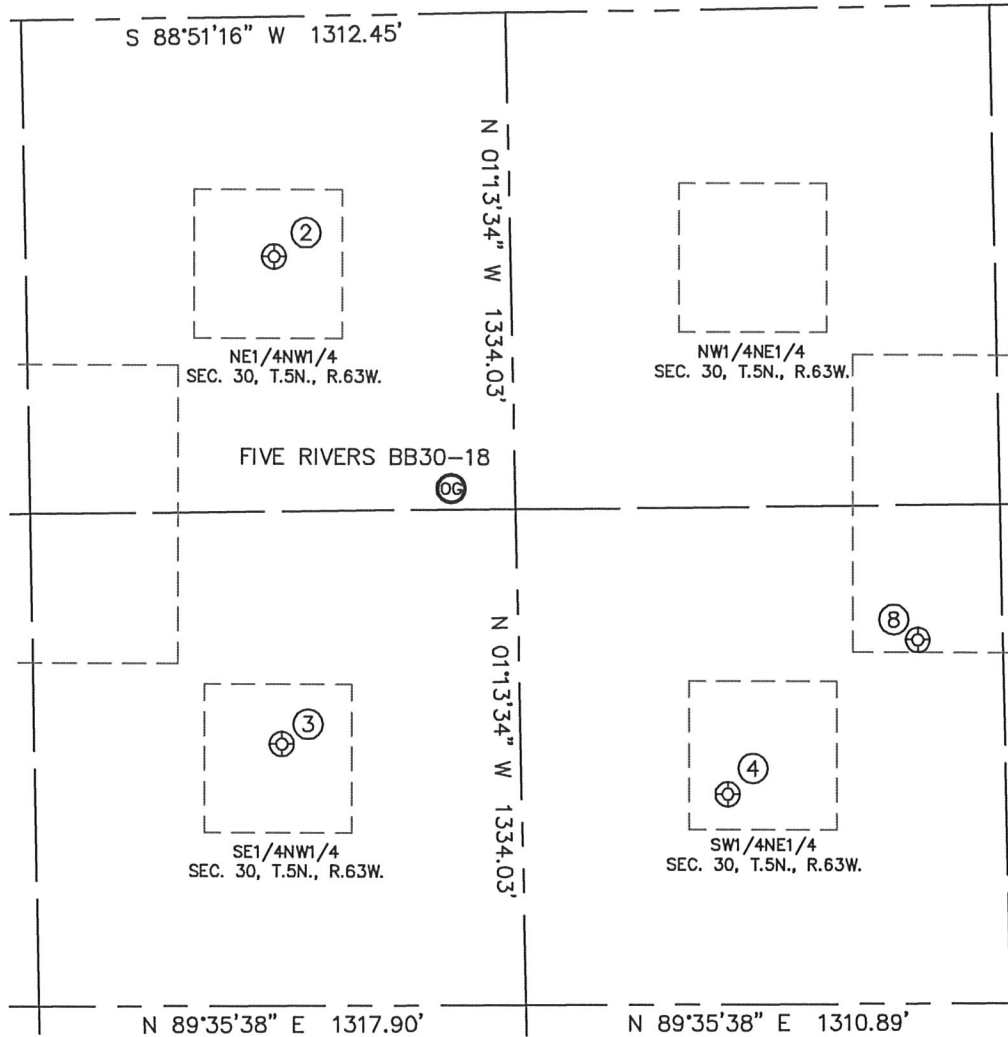
