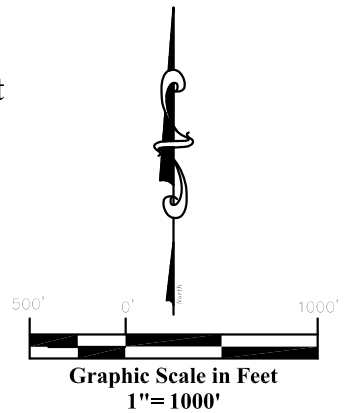
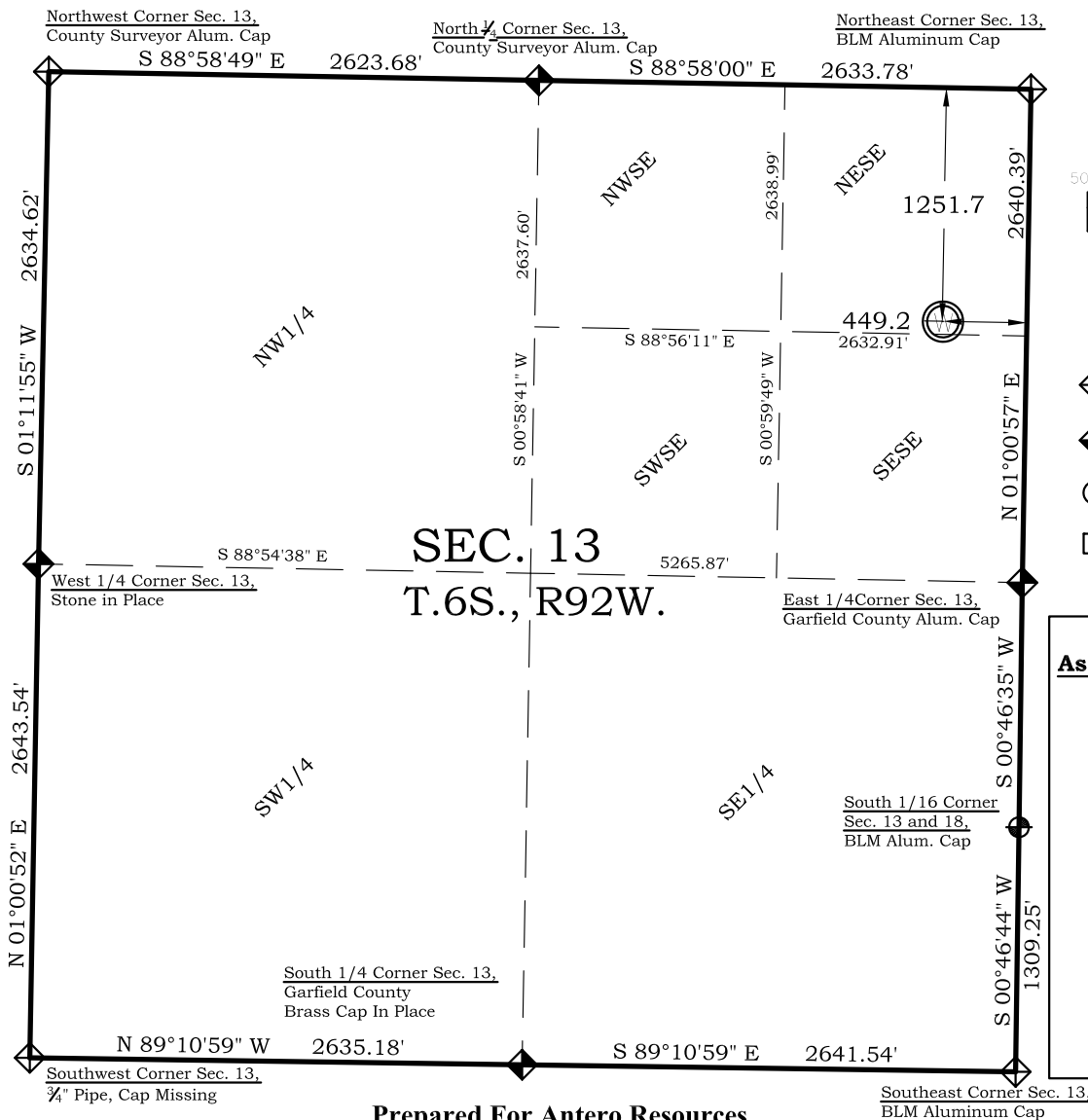


As Drilled Location Plat
