Cheryl,

I have been reviewing the Cricket - Multi C22-30D **Form 2A** (#400053943). COGCC requests the following clarifications regarding the data Noble has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment (OGLA).

1. **Water Resources (Section 14):** Form 2A also indicates the depth to groundwater to be 15 feet bgs for a well located 964 feet away from the proposed well pad. COGCC guidelines require designating all locations with shallow groundwater a **sensitive area** and requiring the following conditions of approval (COAs):

COA 1 - Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system is required.

COA 5 - Operator must implement best management practices to contain any unintentional release of fluids.

COGCC would appreciate your concurrence with attaching these COAs to the Form 2A permit prior to passing the OGLA review. If you have any questions, please do not hesitate to call me at (970) 309-2514 (cell), or email. Thanks.
