The nearest surface water is the Union Irrigation Ditch. Checked sensitive area due to shallow static water level per WW permit 4485 and close proximity to surface water. The reference area is on undisturbed ground immediately adjacent to the north of the location as shown in the "north" location photograph. Noble Energy Inc. requests approval of a Rule 318Aa, Rule 318Ae, and Rule 318Ac exception location: Wellhead is to be located outside of a GWA drilling window, the well will be drilled to a 318Ae infill location from outside of a GWA drilling window, and the wellhead will be located more than 50' from an existing well location.
