The Guttersen D16-28 is being added to this location. The nearest WW (permit 245953) was used for distance. Only WW permit 7060R-R listed static water out of 5 wells checked. Nearest surface water is a dry low area; next closest is Box Elder Creek. The reference area is on undisturbed ground immediately adjacent to the south of the location as shown in the "south" location photograph.
