Railroad is 1.39 +/- miles away from site. Visible improvements within 400 feet of site shown on Location Drawing. Nearest water well approx. 436 +/- miles from site (RECEIPT: 0270785B; PERMIT: 146748-A; USE: DOMESTIC STOCK). This well does not drain into a public water system, it is for domestic use. Static Water Level taken from next nearest water well Permit No. 278127-A. There is an ephemeral stream located 2007 +/- feet southwest of location. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require an electric motor to run the pumping jack unit.
