In accordance with the requirement of Rule 305.e.(1).B. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as a 30-day notice by Petroleum Development Corporation (PDC) of its intention to conduct drilling operations on the captioned wells.

I will be contacting you shortly to schedule a consultation to discuss the location of the wellsite(s), access roads, production facilities and other related matters. The well locations have been staked. Pursuant to Rule 306, you may also use the enclosed postage prepaid postcard to request a consultation or to designate a representative for surface consultation.

Also enclosed is a site diagram that depicts the area, per COGCC rules, within which the well(s) may be located, and the proposed location of the well(s), access road(s), and production facilities. Additionally, enclosed please find a copy of the COGCC's brochure describing surface owner rights and responsibilities, and a copy of the COGCC's on-site inspection policy.


