Wellstar Corporation is proposing to enlarge the existing built pad for the above mentioned location. The Bush Draw Federal #10-2 was drilled as a verticle well and is currently SIWOC. Wellstar is planning to bring back in a drilling rig and drill a horizontal leg to this well on or around 8/1/2010. The pad that was originally built was not large enough to handle the drilling and completion operations. The pad that was originally approved was to be 190' x 350' it ended up being an estimated 185'x 324' (an estimated 1.38 acres disturbed). Wellstar would like to propose to enlarge this pad to an estimated 290' x 355' (an estimated 2.34 acres disturbed). Please see the attached well pad drawings (2).


