DECLARATION OF UNITIZATION AND POOLING

WHEREAS, DELTA PETROLEUM CORPORATION ("Delta"), 370 17th Street, Suite 4300, Denver, CO 80202, is the Operator in and to the Oil and Gas Leases ("Leases") covering the lands described on Exhibit "A" attached hereto and

WHEREAS said Leases grant Lessee {EnCana Oil and Gas (USA)} et al the option, right and power to pool or unitize the leasehold estate and the mineral estate covered by said Leases with other land, lease or leases for the production of oil or gas. The forming or reforming of any unit shall be accomplished by Lessee executing and filing of record a declaration of such pooling and/or unitization describing the unit and

WHEREAS, the Oil and Gas Conservation Commission of the State of Colorado, has not designated spacing units to provide for 320 acre drilling and spacing units for the production of gas and associated hydrocarbons from the Niobrara Formation covering lands described on the attached Exhibit "A" located, in Mesa County, Colorado and


WHEREAS, Delta, as Operator intends to horizontally drill and complete natural gas wells for the production of natural gas from the Niobrara Formation covering lands described on the attached Exhibit "A" and

WHEREAS, Delta desires to pool, unitize, combine and/or communitize said Oil and Gas Leases and lands insofar as they cover the Niobrara Formation in the E/2NE/4, SE/4 of Section 23 and the W/2NW/4 of Section 24, Township 9 South, Range 93 West, 6th P.M.

NOW, THEREFORE, subject to successfully completing the NVega 24-14H as a well capable of producing oil and gas Delta does hereby pool, unitize, combine and/or communitize said Oil and Gas Leases covering the E/2NE/4, SE/4 of Section 23 and the W/2NW/4 of Section 24, Township 9 South, Range 93 West, 6th P.M. as the approximate 320 acre drilling and spacing unit for the production of natural gas from the Niobrara Formation underlying said lands. Said pooling is effectuated pursuant to the terms and conditions of the Oil and Gas Leases.

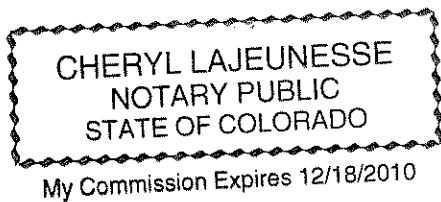
