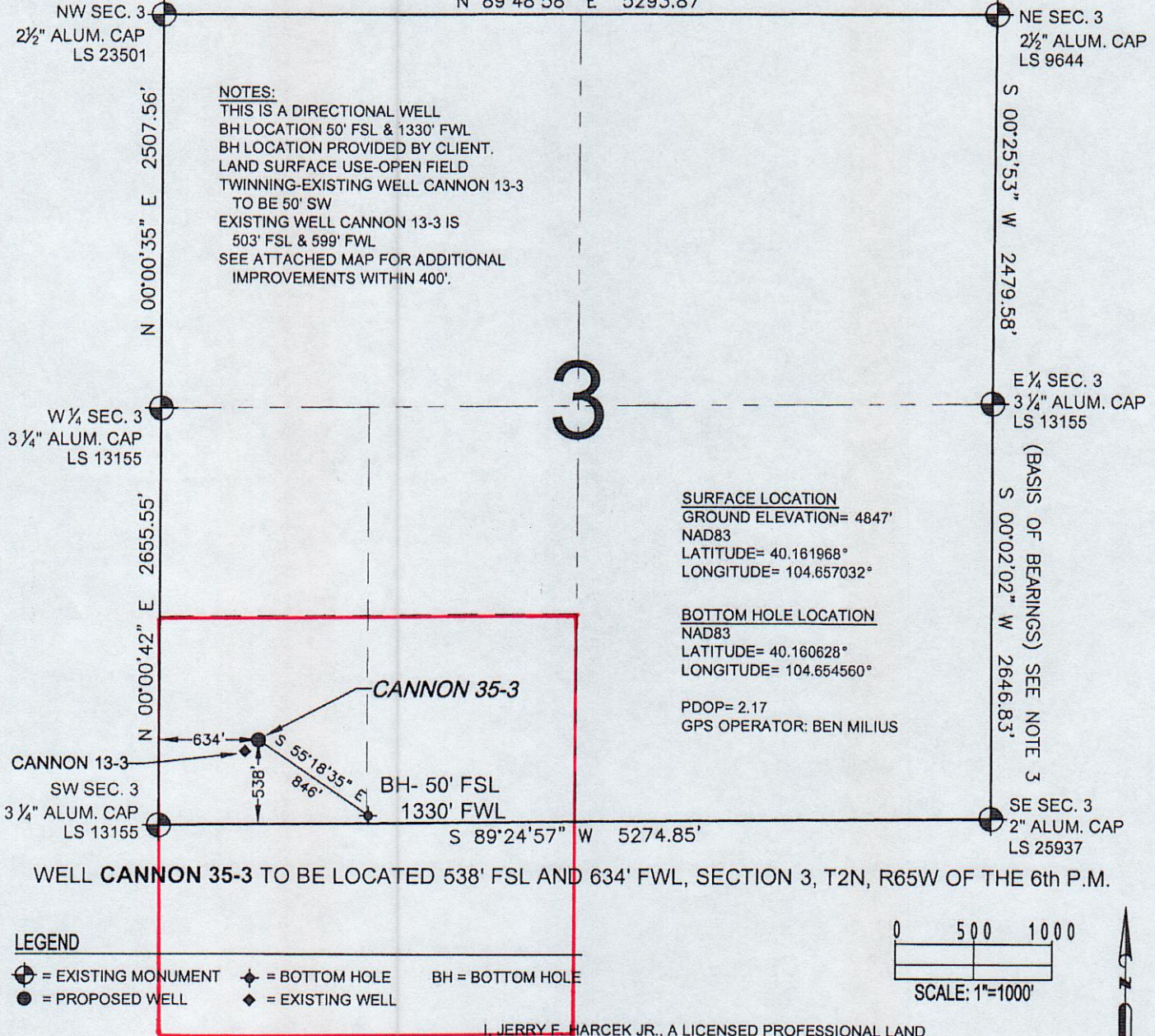

WELL LOCATION CERTIFICATE: CANNON 35-3

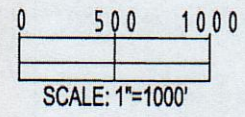

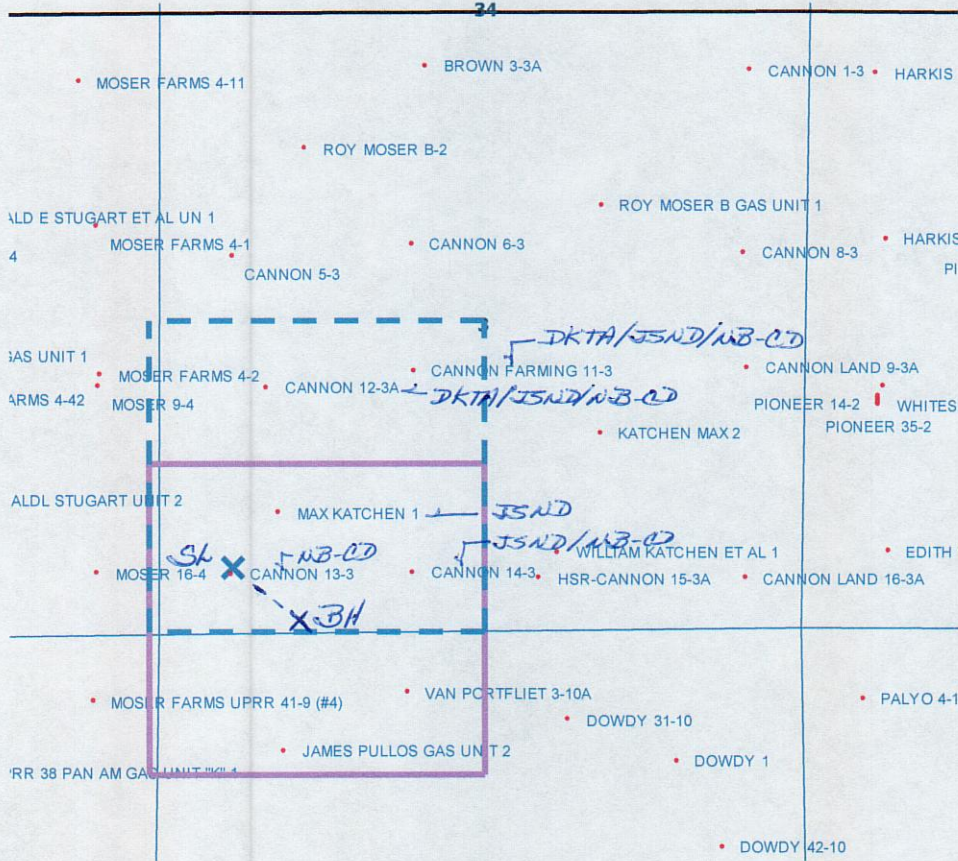
