The window for disturbance will allow for construction of the location, which will be completed approximately 1 to 3 months prior to the rig moving in, with drilling and completion taking approximately 2 to 3 months. Reclamation will begin as soon as the free water is off the pit, either by transferring the water to another drilling location, mechanical evaporation, or solidification with natural soil, cement or fly ash. It is understood that interim reclamation is to begin 6 months after drilling/completion. During drilling and completion the location will be bermed in all areas if wukk ti prevent fluids from leaving the location. This will allow for the holding capacity of 110% of all fluids on locaion being contained., in compliance with the secondary containment requirement. If a tank battery is const4uction on thso lease, it will be surrounded hgy a dike of suffi ent capacit ot contain 110% of the largest storage tank. The pipeline right of way to serve this well will be obtained by Questar Gas Management, under seperate cover.
