Water well permit #11407- was used to determine depth to groundwater. The Heyde 26RD and 26VD will be drilled from the same pad. The wells will be tied into the tank battery facility located approximately 204' SE which currently services the Heyde 1-26 (also located on site), 31-26, 32-26, 41-26, and 42-26. The reference area is located on undisturbed ground immediately adjacent to the west of the location as shown in the west location photograph. The surface owner waived their initial consultation.
