Since there is a problem in receiving an injection permit, what are you preparing to do for mitigation of the contamination source? Extracting water from the interceptor trench to pull the plume back from Grove Creek was approved, but without the injection well, and therefore removal of water from the interceptor trench, please let me know how additional contaminants will be kept from reaching Grove Creek.

This does not need to be a long document, and might even be able to be done via email, as opposed to a formal letter or document, but please include anticipated dates, including when the alternate mitigation plan will be enacted.
