On behalf of Chevron Environmental Management Company, Stantec is providing the attached workplan and Form 27 in preparation for follow up assessment activities associated with the interim reclamation work conducted at two pit sites in South Canyon, Garfield County. The Phase II Site Assessment activities follows the plan we presented to the BLM and COGCC on August 12, 2010. Based on several discussions with the leasing specialist for the BLM, it appears that we will not be able to conduct the installation of monitor wells adjacent to the well pad without a BLM Right-of-

way permit. It is our intent to complete what field work we can this year, while the BLM reviews our application for a right-of-way permit.

Since the Phase II Assessment workplan exceeds the COGCC's 5 meg limit, I have uploaded the document to a FTP site. Directions on accessing the FTP site are provided in the below correspondence. If you have any trouble downloading the documents from the FTP site, please let me know. These materials outline the project's proposed objectives and scope of the assessment work. Our team is seeking the approval of this proposal by the COGCC prior to the initiation of field activities. I would like to schedule the field activities early October, although, I would like to provide the COGCC with adequate time for review. In order to help me coordinate the field schedule, I would appreciate it you could indicate how long it will take to provide comments or approval.
