Water well permit #16150-R was used to determine depth to groundwater. The Moody 31-32D, 41-32D, 42-32D, 32CD, and 32-32D will all be drilled from the same pad. The wells will be tied into a tank battery facility approximately 1,000' to the SW. A separate 2A will be filed for the tank battery facility. The reclamation date is 3 months after spud of the last well on the pad (Moody 32-32D). Petroleum Development Corporation requests approval of a Rule 318Aa exception location: Wellhead is to be located outside of a GWA drilling window.
