Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the wet areas located 88 feet west and 109 feet southwest of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products.

Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system is required.
