PERMIT #19413-S USED FOR STATIC H2O LEVEL. SURVEYOR FOUND AN IRRIGATION WELL THAT IS 479' FROM WELL SITE, BUT IT IS NOT LISTED ON THE CDWR WEBSITE. NO STATIC LEVEL FOR THAT WELL IS AVAILABLE. NEAREST OTHER WELL IS 1,335' FROM WELL SITE & HAD A SWL OF 17' (LISTED ABOVE). NOBLE WILL USE A CLOSED LOOP SYSTEM. THE PRODUCTION FACILITIES WILL BE LOCATED ON THE SAME LOCATION & DEDICATED TO THE WELL LOCATION BEING PERMITTED. PAD WILL BE BUILT EAST & SOUTH OF THE PROPOSED WELL DUE TO SURFACE H2O SHOWN ON HYDROLOGY MAP & WILL BE WITHIN 150' OF THE PROPOSED WELL. SEE DOC #400086078 FOR WELL DETAILS. CROP IS CORN. NEAREST RAILROAD IS GREATER THAN 1 MILE.
