Nearest surface water located 527' west is confirmed as a pit used for the drilling of the DF Ranch 1161-9-44 well. This pit will be reclaimed in the near future. Onsite has confirmed that the slopes for soil are not greater than 10%. Permit # 255719 used for distance. Closest well with SWL is Receipt #9065982 Permit # 94826 located 1.43 miles SE for household only. Location is in Upper Crow Creek Designated Groundwater Basin.
