The Binder 10OU, 10SDU, 32-10DU, 22-10DU, 10CDU, 10NDU (all previously permitted locations) and the Binder 10KDU (a new location) wells will all be drilled from the same pad and tied into tank battery facilities located on site. This 2A amends location 415249 which was previously approved on 1/1/10. The pad was originally permitted for 6 wells and now a 7th well has been added which has shifted the wells 22' to the north. The pad has not moved further south than what was originally permitted and approved. All other distances, measurements and information has not changed. An updated Location Drawing and Multi-well Plan have been attached to this application; all other exhibits have remained the same.
