The Binder 10ADU, 12-10DU, 11-10DU and 21-10DU will all be drilled from the same pad. The Binder 1 is also at the location but is a plugged and abandoned well. Water well permit #0396493A was used to determine depth to groundwater. This location was previously approved on 4/30/10. The Binder 21-10DU has now been added to the pad as the furthest north well. All other wells have not moved. All distances, measurements, etc. have not changed. Due to the additional well on the pad a revised location drawing and well pad exhibit have been attached. All other exhibits have remained the same.
