Cause of spill (e.g. equipment failure, human error, etc.): <u>water line failure</u> Detailed description of the spill/release incident: A 6" steel water line associated with BBC's centralized water system was observed to have had a release due to a failure in the pipeline. Water flowed east along the pipeline right of way where it traveled downhill a distance of approximately 900 ft.	

**CORRECTIVE ACTION**

Describe immediate response (how stopped, contained and recovered): <u>The 6" steel water line was isolated by two valves. BBC contractors bermed an area along the pipeline right of way. A vacuum truck recovered 25 bbls of water from the areas where the released water pooled. The affected soil beneath the release point was removed leaving a small excavation measuring 20ft x 25ft x 6 ft. deep (Figure 2). Soil samples were collected from the sidewalls and base of the excavation and submitted for laboratory analysis. Soil samples were also collected along the entire path of the release (Figure 3).</u>
Describe any emergency pits constructed: <u>NA</u>
How was the extent of contamination determined? <u>Soil samples were collected on 10/12/2010 from the visual extent of the spill area, field screened, and submitted for laboratory analysis (Figure 3). BBC is currently awaiting the laboratory analytical results.</u>
Further remediation activities proposed (attach separate sheet if needed): <u>Following receipt of the analytical results from the soil samples, BBC will formulate and submit a Form 27 outlining remediation activities, if necessary.</u>
Describe measures taken to prevent problem from reoccurring: <u>Additional measures will be taken when processing line locate requests.</u>
