(Docs attached) Closest WW's were monitoring wells that had been plugged. Next closest WW (permit #228532A) in Sec 10 had no static level. Permit 224175 was used for static level. Reference area is on undisturbed ground immediately adjacent to and west of the location as shown in the reference area photo facing west.
