



("Noble") plans to drill the BASHOR PC AA09-22 well (the "Well") at the referenced location which is more specifically described as 2,580 feet FSL, and 1,350 feet FEL which is outside the drilling window prescribed in Colorado Oil and Gas Conservation Commission ("COGCC") Rule 318A.a.(1).

By signing this letter you hereby grant your consent to Noble to locate the Well outside of a GWA window as defined in COGCC Rule 318A.a and waive the directional drilling requirement under Rule 318A.e. Additionally, the Well is being proposed at a surface location approximately 1,094 feet from an existing surface well location.
