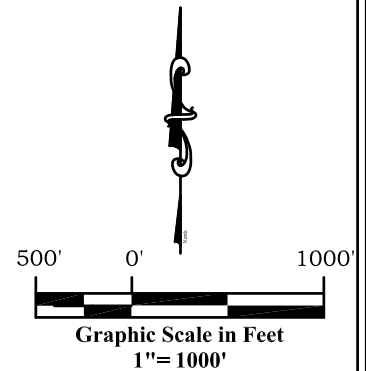
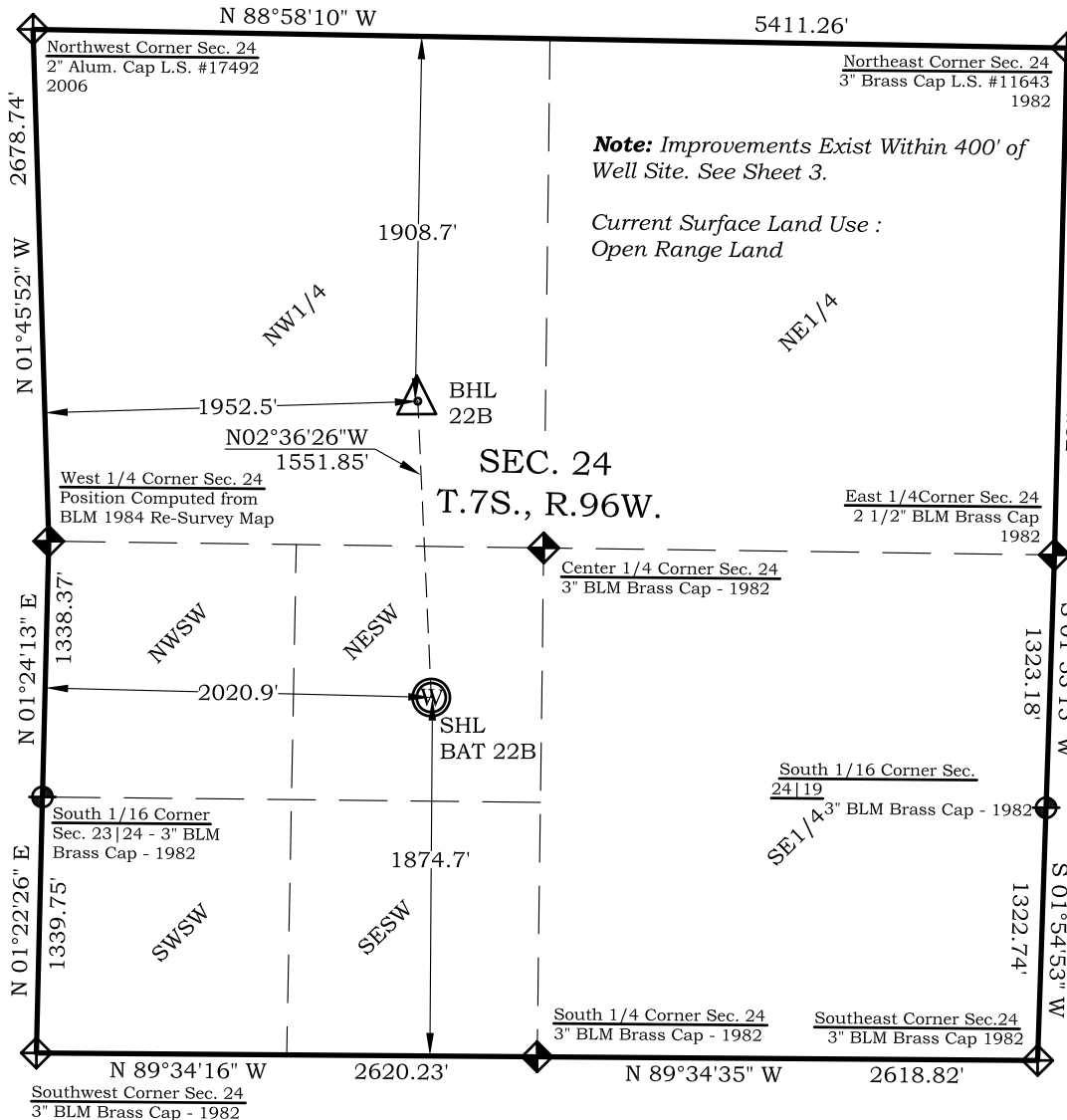


Well Location Plat BAT 22B-24-07-96
