Circulated two bottoms up starting with 10.9 ppg MW in and 10.6 ppg MW out and finished with 11.2 ppg MW in and 11.1+ ppg MW out. Circulated kick out through full open choke at 50 spm / 525 psi SPP. Well was stabilized after second circulation with 11.2 ppg MW.
