Issue:

Well has continued to have bradenhead issues since initial completion. There has been little success in venting bradenhead, as a result the State is requesting bradenhead issue to be remediated.

Procedure:

1 MURU pulling unit

2 Top kill well if necessary, ND WH, NU BOPs

3 POOH w/ 203 JTS 2 3/8" 4.7# J-55 TBG.

4 Rig up W/L and run gauge ring to 1,600'
if no issues with gauge ring run, set CBP @ ~1,550'
if problems with gauge ring run, contact Kirby and Denver

5 Pressure test plug to 2,000 psi

6 Perf 4 spf @ ~1,500'

7 Rig down W/L

8 Establish injection into perfs with water

If injection is not established, call Denver to discuss alternate procedure that will be discussed and agreed upon with the State

9 RIH with 2 3/8' tbg and retainer, set retainer @ ~1,450'

10 Rig up cement company and pump 50-100 sacks (depends on injection rate with water through perfs) of G cement

Save copies of cement tickets for Denver and State

11 Let cement set and notify Kirby and Denver on status of Bradenhead

12 Drill out retainer and cement

13 Reland 2 3/8" tbg @ ~6,266' (+)

14 ND BOPs, NU WH

15 RDMO

Surf ~ 810

Someone wrote "TOC" on CBL

@ ~ 1100 whereas

CBL (dated Nov 12 2003)

doesn't show good cement

until ~ 3660.
