Nearest water well is permit #: 45932-MH -, located SWSE Sec. 20 4N 67W, ~ 2,045' S-SE from the location reference coordinates. This well is a monitoring well. Static water level determined from water well permit #: 12802-R -, located SWSE Sec. 18 4N 67W, ~ 1.04 miles from the location reference coordinates. There is no elevation listed for this well, however the topographic map shows it listed as ~80' below the elevation of this 2a location, thus the vertical distance from the elevation of this 2a location to the static water level for that water well (10' + 80' = 90') has been used as an estimate for depth to ground water. Reference area is immediately adjacent (north) of location, thus the location pictures are also reference area pictures. Permits listed under "Related Forms" have yet to be submitted and remain in DRAFT status. These will be submitted as soon as is practicable. HRM Resources requests and exception to Rule 318A, request and associated lease w/ addendum consenting to such surface locations are attached.
