Operator is prohibited from allowing any fluids to flow back to the fresh water Frac Pit and if fresh water for the Frac Pit does not originate from a municipality or an irrigation source (well, pond, canal, etc.), the source of origination will be provided to the COGCC. We are requesting an expedited approval to start construction on the pit 12-1-10.
