Attached are documents related to the spill/release at the Cozzens tank battery located in the SENW Section 9 – T6N – R65W that occurred on 6/28/09. A Form 19 was previously submitted on 7/7/09 (Spill #1944356). Due to an oversight, confirmation soil samples were not collected for laboratory analyses prior to site restoration. As a result, soil samples were recently collected from six locations within the excavated area. Lab results indicate compliance with Table 910-1 standards. Based on these results, PDC is requesting No Further Action.
