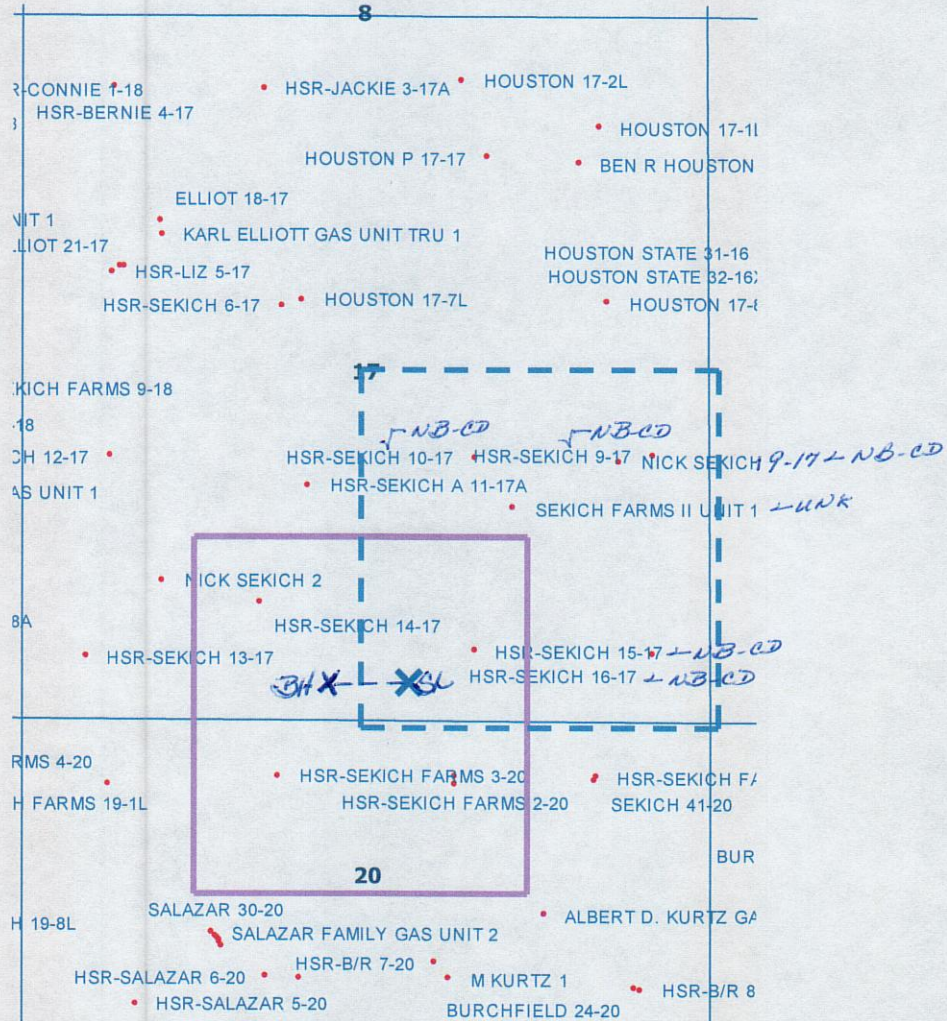

Bottom Hole Located SE/4SW/4, Sec. 17-T3N-R67W (Dashed line).

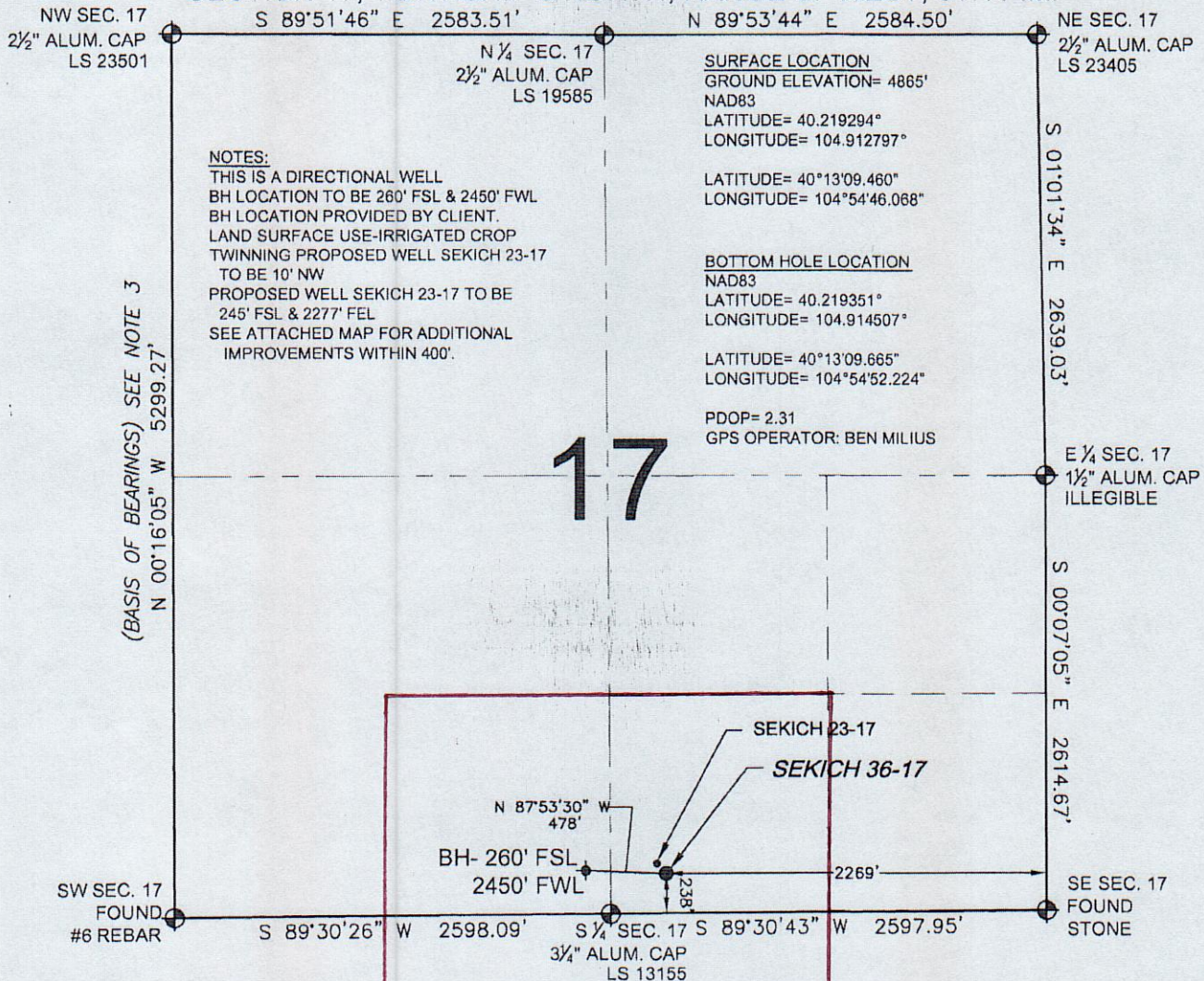

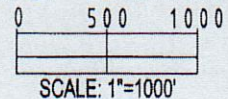

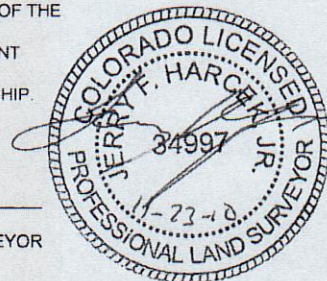
