15. Comments:

Oxy is both the surface and mineral owner; Rules 305 and 306 are waived. The 697-17B well pad has not yet been constructed. Oxy had previously permitted 12 wells for this pad, and 7 wells will be added. A semi-closed loop system will be utilized, and Oxy will provide appropriate housing for essential personnel in order to conduct safe, efficient drilling operations. The plat references a "flare pit;" this is not a pit, but a flare box. Per GarCo Vacation Ordinance dated 10/5/1987, CR 213 is now Oxy's private property north of Sec 8, 7S, 97W, 6 PM. The CDOW pre-consultation meeting occurred July 16, 2010. Oxy will comply with Notice to Operators (NTO) Drilling Wells on the Roan Plateau (June 12, 2008). Please note that the reference area is included on the hydrology topo map.
