NEI's proposed wellbore spacing unit consists of the SW/4SW/4 of Sec. 1 and SE/4SE/4 of Sec. 2 and the NE4/NE4 of Sec. 11 and the NW/4NW/4 of Sec. 12, T4N, R65W, creating a 160-acre wellbore spacing unit. NEI is the only owner within the proposed wellbore spacing unit, therefore NEI hereby attests that no notice letters are required under COGCC Rule 318A.e.(6).



