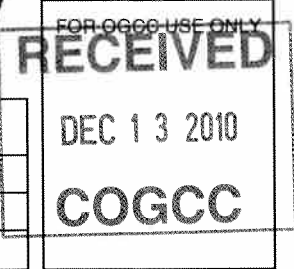

5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

The 697-17-56B well was originally permitted to an MD of 9437' in the WMFK formation, spacing order 510-15, and the ILES formation, spacing order 510-48.
The actual total MD is at 9533', an increase of 96', which did not change the objective formations.
