Rick,

Attached is an application for a multi well pit. It is the functional equivalent of a centralized E&P waste management facility, but with three significant differences;

1. It will have a limited duration, not to exceed three years (the defining feature in our rules)
2. It will not require a special use permit from the county
3. The operator submits a Form 15 instead of a Form 28.

A fourth possible difference is the requirement for financial assurance. I haven't decided what to require, or more to the point, what I can require. Otherwise, please review the subject application with respect to the requirements for a centralized facility.

Also, please let me know how much of your purchase order has been used. I want to avoid the angst associated with exceeding the authorized amount.
