Attached is the 6 hour temp log run in lieu of the 12 to 48 hr CBL on the Rose Ranch 23-6C1 (A22W) well drilled by Nabors M13. This is the 4th of 10 production holes to be drilled on this pad.

Full returns were observed throughout the cementing operation and final differential pressure was as expected.

Bradenhead pressure on this well are as follows:

6 hours = 0 psi
12 hours = 0 psi

24 hours = 0 psi
48 hours = 0 psi
72 hours = 0 psi

Bradenhead pressures remain zero and we will continue to monitor bradenhead pressure daily until the CBL's are run after the rig has moved off the pad.
