PLEASE NOTE ENCANA WILL BE UTILIZING CLOSED-LOOP SYSTEMS FOR BOTH THE DRILLING RIGS WE WILL BE RUNNING IN THE DJ BASIN. PLEASE TAKE THIS INTO CONSIDERATION. LOCATION IDENTIFICATION, CULTURAL AND WATER RESOURCES DATA ARE BASED OFF THE EXISTING RASMUSSEN 22-28. This pad will flow back approximately 1,080 feet northwest to the Rasmussen C Unit #1 tank battery (Location ID 322889). Footprint of the Rasmussen C Unit #1 tank battery will not be increased, thus not requiring a separate Form 2A. Encana Oil & Gas (USA) Inc. requests approval of Rule 318Aa exception location: Wellhead is to be located outside of a GWA drilling window. Waivers are attached.
